Charis started in 2008 as an outreach project to people in the sex industry from a local to church to address a need in the community. In 2014 Charis Tiwala ("Charis") became a registered charity.

Charis is a Christian charity in Hertfordshire, offering support and assistance to people who are in, or affected by, the sex industry.

Our vision is to see a society where everyone is valued, treated with dignity and able to live a fulfilling life; without the danger of being trafficked or sexually exploited.

At Charis we focus on:

- Preventative work
- Regular outreach
- Practical and emotional support

Charis exists to give people in the sex industry the opportunity for choice again (where so many choices have previously been taken from them); a choice to exit if they wish, and a choice to rebuild a new life as they would choose to live it.

#### **ABOUT THE ROLE**

Job Title: Key Worker

**Responsible to:** The Key Worker will report to the Team Manager

**Contract**: One year fixed contract (with the potential of becoming permanent at the end of the year subject to funding).

**Hours per week:** 2 days (16 hours) or 3 days (24 hours) per week, including one evening per week. There is potential to have some flexibility around working hours.

**Annual Salary:** £23,000 - £25,000 full-time

**Holiday entitlement:** All employees are entitled to 5 working weeks holiday full pay, plus statutory bank holidays, the employee's birthday (if it falls on a working day) and the week between Christmas and New Year.

**Job Overview:** The Key Worker's role is to provide holistic emotional and practical support and assistance to people who are in contact with Charis, in a professional and personable way.

## **Responsibilities:**

- To have a caseload of individuals to key work, providing high quality support appropriate to their expressed needs.
- Receiving new referrals, gathering information, writing support plans, delivering support, and signposting utilising both internal and external resources.
- Building, maintaining, and ending positive relationships with women in contact with Charis.
- Monitoring and maintaining accurate and up to date records, forms and plans in line with Charis's policies and procedures.
- Adhere to data protection requirements in regard to personal or sensitive information.
- Participate in delivering Charis's outreach service; including visiting venues, on street outreach and online outreach.
- Contributing to delivering weekly Bible studies for the women Charis works with.
- Responsible and accountable for participating in an effective staff team and the general running of Charis's service.
- Actively engaging with other organisations to ensure high level of care for women in contact with Charis.
- Attend training or meetings as agreed with your line manager.
- Attend regular clinical supervision (provided by Charis).
- Uphold the values and ethos of the charity, understanding the objectives and vision of the charity.
- Be familiar with the policies and procedures of the charity, ensuring that they are implemented in all aspects of Charis' work.

# **Requirements and/or Qualifications**

- Some experience working with adults at risk is preferable.
- A strong understanding of professional boundaries.
- To be able to work effectively unsupervised and as part of a team.
- An understanding of good practice in safeguarding.
- Clear communication skills; both in writing and orally.
- An ability to work flexibly in response to changing organisational needs and the changing nature of the work.
- An understanding of equality, diversity and inclusion.
